## Production


DHA collects production data only on hardwood plywood

Follow hardwood veneer and engineered flooring thru other means

Notwithstanding domestic economic growth and 2 AD/CVD orders in place against decorative plywood and multi-layered wood flooring from China, the North American industry is not enjoying these positive factors with increased production

Why?

## Production Flat and Import Share Steady



2008 was the highest year of combined production

2013,2014 and 2018 followed

Even though the economy and housing both recovered from the 2009 lows, China's share in absolute and percentage share grew

Domestic plants closed and continue to close, shifts laid off, veneer suppliers impacts, the entire value chain

## We Continue to Loose Domestic Markets

Furniture left over the last 2 decades to China

China is now the world's largest wood panel manufacturer world – half the global production


Kitchen cabinets are next and they filed an AD/CVD case against China

A major AL co. laid off 40% of their employees, a MO co. in business 70 years closed, and Masco getting out of the business

## Major Tactic to Circumvent: Radiata Pine

Decorative Hardwood Plywood put a decorative softwood face on it

Avoids 194% AD/CVD duties

Commerce Department determines recently developed product to circumvent

Duties apply retroactively to September 2018





## How You Can Help?

#### New products

Evidence or suspicion of cheating

- E.g., duty evasion, transshipment, mismarking of grade, price, country of origin
- Tools for the domestic industry:
  - File an e-allegation regarding the evasion activity with CBP
  - File an Enforce and Protect Act allegation with CBP
  - False Claims Act filing (Bounty Hunter)

# Administrative Reviews of Multilayered Wood Flooring AD/CVD Orders

The 6th administrative reviews are ongoing and the 7th administrative reviews are underway.

Final determinations in the 6th administrative review are currently scheduled for:

- AD: May 30, 2019 (may be extended)
- CVD: June 6, 2019 (may be extended)
- Proposed rates were 50%

Preliminary determinations in the recently initiated 7th review are currently scheduled for:

- AD: Sept. 3, 2019
- CVD: Sept. 3, 2019

# Key Facts / Arguments in the KC AD/CVD Case – Major Domestic Market for U.S.


Subject imports increased by 57 percent during the POI, reaching about 18 million cabinets and \$1.4 billion in 2018

U.S. demand is strong and growing, but Chinese imports are taking market share at the direct expense of the domestic industry

Chinese imports compete head-to-head with domestic product in substantially all of the U.S. market and consistently undersell domestic products

The domestic industry's financial performance has declined significantly as a result of Chinese imports

# Trade: China – One mind and One mission but...

China has a Game Plan

China is a communist, mercantilist country

Has target growth industries: world's largest wood panel manufacturer (50%)

Dominate the entire value chain: moldings and frames next

Political vulnerability – Hong Kong and Tiananmen Square

Slowing economy and unemployment

**Limited wood resources** 

Largest importer of illegal wood in the world

## Trade: U.S. -2 minds and 2 mssions

Free traders versus fair traders: Trump is fair trader

Domestic industries injured have remedies: slow and expensive

China has a circumvention plan before the orders go into effect

U.S. supplies the domestic high end markets or the entire US market

- China has "clout" politically in U.S.
- ➤ Importers like IWPA support China
- Downstream industries and consumers "hooked" on cheap
- **►IKEA** and Wall Mart world

### REGULATIONS

Formaldehyde: EPA Title VI

"Fabricators"

Closes "arbitrage" loophole

EPA TSCA Formaldehyde Risk Assessment underway

China announces a "formaldehyde free" resin for the wood industry (Huntsman Chemical)

HTS Codes: 0% tariff on birch

Devalues maple forest by 8%

Encourages "arbitrage"

Gives preference to the largest illegally harvested birch forest in the world

## Log Exports

China is the world's largest importer of logs

Legal and illegal logs are fungible especially in engineered wood products

Americans are split by log producer (\$) or log user

New York Times article on MO walnut

China uses "non-tariff trade barriers" to keep veneer and other value added products from those same logs from entering China

"Labor theft"
